

## INSTRUCTIONS TO REQUEST BASIC REVISION (EVALUATION) AS QUALIFIED BREEDING STOCK (206)

Verify the available of possible promotions for this service at <a href="https://www.lgancce.com">www.lgancce.com</a>

- **1.** Access the PRE Stud Book web site at <a href="www.lgancce.com">www.lgancce.com</a>. Click on the tab **Documentation**; select and download the form "**International Request for Service.**"
- 2. Complete the form, indicating Request for Service 206; make sure that you have filled out all of the boxes on the form.
- **3.** Before indicating the fee, consult the table with the current fees for the service requested. Request the price list from your local Collaborating Association; should your country not have an association, consult the applicable fee for said service/s at: <a href="mailto:international@lgancce.com">international@lgancce.com</a>.
- **4.** Indicate the name of the horse or horses for which you are requesting Basic Revision as Qualified Breeding Stock, as well as the code for each horse, in the corresponding section.
- 5. Once you have filled out the application form, sign it and then proceed to pay for the service through the LG PRE Stud Book Collaborating Association in your country, (consult contact information on our web site). If no Association is available, make your payment through our web site at <a href="https://www.lgancce.com">www.lgancce.com</a>

- **6.** Either the Collaborating Association in your country or the main LG PRE Stud Book office will inform you about the established dates and itinerary for the Revision in your country.
- **7.** Should your horse or horses be considered Approved Breading Stock, the LG PRE Stud Book representative, at the time of the evaluation, will indicate this merit on the horse's ID with the corresponding certifying sticker.

**NOTE**: All dates and itineraries for LG PRE Stud Book Revisions will be established by the Collaborating Association in your country, in coordination with the main PRE Stud Book office, in keeping with the number of requests and horse requesting this service.

Breeders will be emailed with timely information; also, this same information will be uploaded onto the LG PRE Stud Book web site.
