- To facilitate the refund process, it is a good idea to include a copy of the bank receipt that corresponds to the mistaken amount for which you are requesting the refund.
- This form is not valid if there are amendments, erasures or if there is no signature.

(1) The beneficiary is responsible and accepts all bank charges/fees originating from the refund.

(2) From January 1 to December 31. When payment is made between November 1 and December 31, refunds may be requested until January 31 of the following year.
