- **(2) From January 1 to December 31. When payment is made between November 1 and December 31, refunds may be requested until January 31 of the following year.**
- To facilitate the refund process, it is a good idea to include a copy of the bank receipt that corresponds to the mistaken amount for which you are requesting the refund.
- This form is not valid if there are amendments, erasures or if there is no signature.

All personal information supplied on this form will be included in a file for which the National PRE Breeders' Association of Spain, ANCCE, with tax registration nº G-41071960 is responsible, as foreseen in the legislation of Spain, Law 15/1999 regarding the Protection of Personal Data. Said file has been registered in the General Data Protection Register to be able to handle the services provide by the association, including management, fiscal and accounting aspects of its members and breeders.
